

# EPAs 2025 Qualifying Exam

#### EPAs and the QE

- For the 2024 QE, programs who adopted EPAs,
  - Reduced administrative tasks for programs and applicants,
    - □ 2024 graduates and PGY-4 applicants were not required to complete GME section
    - □ Programs completed a "global attestation" for applicants
- With the 2025 QE,
  - The GME sections with clinical/non-clinical rotations no longer required for all applicants
    - ☐ A modified GME section
  - PDs complete a "global attestation" for 2025 graduates and any PGY-4 applicants
    - ☐ Electronic attestation sent via email to the program director
    - Graduates prior to 2025 are required to request an individual attestation to be sent to the PD via their portal
- Programs should keep accurate trainee roster records

# **Application Tiles**



#### Modified GME section

- Provide information on any previous general surgery program and upload certificates from previous program(s)
- Upload ABS approval letters for:
  - Extension of training beyond June 30
  - Credit for foreign medical training (1 to 3 years of credit)
  - International rotation (rotation(s) completed outside the U.S)
  - Flexible rotation
  - Six-year option (where 5 years of residency are completed over 6 years)
- Upload AGCME letter approving PGY-4 chief rotations

#### 2025 QE

- OP report and FLS/FES due by June 6 (ABS requirements: 850 total cases, 200 chief cases, 25 TA cases, and 40 surgical critical care patient management cases)
  - Defined category numbers = AGCME requirement
- Able to register and schedule Pearson center while application is under review
  - May be rescinded if application is incomplete
- Upload all supporting application documents
- Submit an accommodation request at time of application

# 2024 QE — Thursday, July 17

- Encourage your residents: Apply and Register early!
- Exam centers have limited capacity; will likely fill up well before exam, particularly in urban areas
  - Delays = may result in travel to a more distant center
- Applicant responsibilities
  - Monitor portal for updates
    - Access exam authorization letter to schedule Pearson center

#### Exam Structure

- 4 exam sessions of 115 minutes
  - Unable to review or change answers once a session has ended
- A scheduled break may be taken after each section
- A break "bank" of 70 minutes
  - Manage/decide how much break time is used (if any) between exam sessions
  - Unused exam time from previous exam session will be added to the break bank
  - Pearson VUE does not monitor break time

# Testing Accommodations - QE

- ADA accommodation—learning differences and ADHD
  - Formal request with comprehensive report from qualified professional
    - □ Double exam time; exam administered over 2 days
    - ☐ Separate quiet room; not all Pearson centers have a separate room
- Lactation Accommodation: have an additional 60 minutes added to the break bank (a total of 130 minutes of break time)
- Pregnancy Accommodation: frequent breaks with an additional 15 minutes of exam time for each of the 4 exam sessions
- Other Medical Conditions such as, but not limited to
  - Glucose monitoring supplies, water, snacks, and/or medication

# FLS / FES

- FLS / FES: required for 2025 QE application to be approved
  - Note: your current PGY-4 residents are exempt
    - ☐ Their applications are formally approved in their chief year
  - Should be completed earlier in training, preferably by the PGY-2
    - □ Not as check off at the end of training

#### Post-Residency – Vascular Surgery Fellowship

- To apply for vascular surgery certification following a 2-year fellowship, applicants must have:
  - An approved general surgery QE application with the ABS
  - Meeting all requirements for general surgery, including:
    - ☐ FLS and FES certification
- Do not need to take the general surgery QE and CE
  - May independently obtain general surgery certification
- Encourage your chief residents to apply to this year's QE

# PGY-4 Applicants to the QE

#### QE After PGY-4

- Must have program director recommendation for application access
  - Programs to submit names of PGY-4 residents by March 1
- Case log submitted in June of chief year
  - Chief cases not required at time of application
- Counts as one of the four exam opportunities for the QE
- QE results included in program's 3-year summary reports
- May *not* take CE early
  - May only take CE after successful completion of residency as attested by program director

## PGY-4 Applicants

- QE application submitted as a PGY-4 is contingently approved
- For application to be formally approved, all PGY-4 applicants must submit supplemental application materials during the chief year:
  - Updated case log
  - Any ABS approval letters received during the chief year
  - FLS/FES if not previously submitted
- Both PDs and applicants must submit two attestations, one when applying as PGY-4 and again as chief resident
- QE application must be approved before able to register for the CE

# Certifying Exam

## Registering for Certifying Exam

- Select/register for CE at the time QE results are posted to candidate portal
  - Must pass QE to register for CE
- Results of July 17, 2025 QE will be available approximately 4 to 6 weeks following the exam
  - About mid- to late August 2025
- A full and unrestricted medical license is required to register for the CE
  - This does not mean having a full and unrestricted medical license by the time a candidate takes the CE
    - □ Either in November 2025 or March 2026

#### CE – Format

- Exam will be virtual via Zoom
  - Three sessions of 30 minutes
  - Must report 30 minutes prior to first session for check-in with proctor
- Prior to the exam
  - Mandatory Attendance at a Candidate Technology Briefing
  - Must be completed in the same physical location and with same equipment as on exam day
- Most common cause of technical failure: internet connection on the candidates' end
  - O Less than 1%

# Leave Policy & Required Weeks of Training

# ABS Family Leave Policy

- An additional four weeks off is permitted twice in training:
  - Once in the first three years
  - Once in the last two years
- Documented leave for:
  - New child (birth/adoption)
  - Seriously ill family member (child, spouse, parents)
  - Resident's own illness
  - Bereavement

#### Training Time – Added Flexibility/Averaging

- 48 weeks of full-time clinical experience each year
  - Other 4 weeks are considered non-clinical such as
    - □ Vacation / Meetings / Conferences / Early departure for fellowship
- Without family leave, training must average
  - 144 weeks in first three years / 96 weeks in last two years
- With family leave, training must average
  - 140 weeks in first three years / 92 weeks in last two years

#### Non-Clinical Time

- 4 weeks of regular non-clinical time used for vacations, conferences, interviews, early departure for fellowship, etc.
- 4 weeks of leave time
  - Total of 8 weeks of non-clinical time
  - Preserving some non-clinical time for other uses, such as vacation time

# ABS Approval Letters

# Prior ABS Approval

- Must be requested by the program director on resident's behalf
  - Allow a minimum of 3 to 4 weeks for processing
- Extensions of Training Beyond June
  - Either for a medical leave or other off-cycle training
- International Rotations
- Flexible Rotations
- Six-Year Option
- Credit for Foreign Training
- ABS approval letter added to applicant/resident record

# Leave Policy and Chief Experience

- 48 weeks of chief experience remains an application requirement
- Chief rotations may be completed in PGY-4 with prior ACGME approval
  - Requests are submitted to the ACGME
- Approval of PGY-4 chief rotations submitted
  - With your residents' QE application; upload via the GME section
  - With programs' written requests for events that occur in a resident's chief year as such:
    - □ Extension of Training
    - □ International or Flexible Rotations

# Extending Chief Year

- With advance approval
  - Extend training through end of August
    - ☐ Extension of training may occur for a variety of reasons and is not limited to family leave
    - □ Apply as PGY-4 if chief year is extended beyond August 31
- Take that year's QE
- Final attestation letter from PD is required:
  - When your resident completes training
  - Before you resident can selection a CE assignment
    - ☐ If training is completed beyond August 31, registration for CE will be dependent upon available spots in the exams
      - May need to wait until the next academic year

### Six-Year Option

- Complete 5 clinical years over 6 academic years
  - Not applicable when dedicated year(s) of research or for the completion of a fellowship are completed while in residency
- Training in a single program
- May take up to 12 months off, with prior ABS approval
  - Uploads this letter in GME section
- Used for any purpose, including but not limited to
  - Medical, maternity, family leave
  - Volunteerism
  - Educational opportunities

#### Flexible Rotations

- Customize up to 12 months of rotations in the last 36 months of training
- Must meet all application requirements
  - 48 weeks of chief rotations in the content area of surgery
  - If flex rotation is in chief year and is **not** in content area of surgery:
    - Must include ACGME approval of PGY-4 chief rotations for the ABS to consider the request
      - The ABS does not need to separately approve PGY-4 chief rotations
      - Your residents upload this approval letter in the GME section

#### International Rotations

- ABS now accepts rotations of 2 weeks in length
- If rotation is completed during chief year, request must include
  - ACGME approval of a PGY-4 chief rotation
- Request will not be considered without this approval
- Your resident uploads this letter in the GME section

# ABSITE

#### ABSITE – Data Forensics – Caveon Test Security

- Every resident's answers are compared to every resident who took the ABSITE
  - Performance on new vs. used questions
  - Response time
  - O Item visits
  - A shared history: even if matches are from different programs
- Identifies irregular behavior where likelihood of a match occurring randomly is less than ~ 1 in 31.5 million

# Exam Irregularities

- When an irregularity or a security violation occurs:
  - PD notified of individuals involved and asked to investigate
    - ☐ **All** results withheld pending outcome of investigation
    - □ Flagged results of *all parties involved* withheld permanently as "not reliable"
    - ☐ Inform your residents of the consequences
  - Subsequent offense: may result in exam held at Pearson VUE with all add'l expenses paid by the program
  - Any disciplinary actions: at program director's discretion

## Irregularities - 2025 ABSITE

- For the second time in three years, an exam copyright infringement occurred with this year's ABSITE
- Some possible changes being considered by the ABS are:
  - Beginning with 2027 ABSITE and thereafter, the ABSITE would have all new questions
    - ☐ An increased and ongoing effort by the ABS volunteer exam writers and exam development and psychometric staff
    - ☐ Increase of the per exam cost for programs
  - Shortening the current 5-day window for all programs

#### 2026 ABSITE

- 2026 ABSITE Friday, Jan. 30 to Tuesday, Feb. 3
  - Fee \$100 per exam
- Pre-registration of all examinees
- ABSITE order form pre-populated with trainee roster data
  - Error on order form = an error on your trainee roster

#### 2026 ABSITE

- ABSITE is open to:
  - Trainees in a clinical position
  - Trainees currently in research/lab year(s)
  - Trainees hosted from another ACGME-accredited program
  - Former residents (either prelim or categorical) and who left residency no more than 24 months ago
- ABSITE is not open to faculty
- A scheduled, optional, 45-minute break during the exam
  - Available to all residents, including for those who are lactating and may not require an accommodation of extra exam time

#### ABSITE Order Form Includes:

- Name of *all* examinees
- Clinical Level or Non-Roster Trainee
- Host program must be an ACGME general surgery program
- Testing Accommodations (time and a half 1.5x/double time 2x)
  - Offered by the Program and noted when placing your order
    - □ Not a guarantee of accommodation on QE
    - □ Additional exam time may not be needed for lactating residents as 45-minute break between exam session is an option

#### **ABSITE** Registration Codes

- Unique to each resident
  - Includes resident name, clinical level, accommodations, host exam site if applicable
- Not transferrable
- Order form = final exam data (not trainee roster)
  - o name and clinical level as listed on order form will appear on results
- Corrections to name/clinical levels are not accepted:
  - Once exam window has started
  - After exam has concluded
  - Once results are provided to program

#### Changes to ASBITE Order

- Minimum of two business days to make change
  - No same day changes
  - No changes once the window opens
  - No changes after completion of the exam
  - No changes once results are posted
- \$350 fee per change

#### ABSITE – Check Readiness Tasks

- ITS reported several programs with connectivity issues
  - Run System Check
    - □ does device meet minimum system requirements?
  - Launch Secure Browser
    - □ are there programs (.exe) running in background that prevent the launch of browser?
  - Evaluate Network/Test Simulation
    - how many devices running at same time on same network? Laptops vs. desktops?


#### **ABSITE** Results

- Only parent program will receive the results
  - Once fee is paid in *full* and seating chart is received
    - Will not discuss with residents; referred to program
    - ☐ Results: pdf files to be saved to your records
    - □ *Individual score reports not retained*; keep only summary reports with all residents listed
  - Transcripts are not available to residents or any third party
    - ☐ Encourage your residents to save their reports to their personal files

#### Program ABS Program Portal


- Program Log-in
  - Shared by Program Director and Program Administrators(s)
  - Changes annually for the academic year
  - Retain/save in your records
- Program Documents
  - Program QE/CE Performance Reports
  - QE letters for candidates
    - ☐ Letters beginning with 2022 graduates remain on portal
  - ABSITE Results
- Trainee Roster
- ABSITE Order Form
- A new Program Portal is coming!



#### Trainee Roster


- Quickest path to the least stressful ABSITE and QE
  - Accurate rosters
  - All information is provided and verified by the program (not the ABS)
  - O ALL fields are editable make corrections!
  - Notify ABS of name changes
- Roster is the foundation for
  - Access to the 2026 QE application
    - ☐ Each resident must be listed as a level 5 and completing in 2026 to have access to next year's QE
    - □ No QE letter = listed incorrectly on roster
  - O ABSITE
    - □ Not on order form = not listed on trainee roster
    - ☐ Adding resident to order will **NOT** add resident to trainee roster
